New Advertising Policy

Products bearing aHR1 brand may not be advertised either in print media (catalogs, newspapers, magazines, flyers, etc.) or online (websites, forums, Ebay, and other "auction" sites etc.) by dealers or their subsidiaries below suggested retail price, Excluding discontinued, non-current and closeout Hard Rock products.

While we appreciate your efforts to comply with our new policy, which is designed to bring our distributor/dealer network better value, we are compelled to tell you that failure to abide by these terms will result in immediate loss of your "Dealer" pricing on HR1 brand products

Terms

New dealers are set-up on credit card or C.O.D. terms. Once history is established possible terms may be negotiated.

Terms for approved North American dealers are net 30 days from invoice date.

Orders from overseas distributors will require credit card or wire transfer prior to shipment.

Shipping

Orders will be shipped via UPS Ground unless another method is specified. All products are F.O.B. Spokane, Washington Dealer is responsible for all shipping charges.

HR will ship only direct to dealer. Drop shipments will not be allowed.

Order Accuracy

HR strives for the best order accuracy available. Each order is inspected twice, then inventoried into cartons, with cartons weighed and marked to log carton contents. Damage or shortages are extremely rare insuring best quality and timely delivery to you. If a shortage is detected, it must be reported within week one of delivery. To insure accuracy all orders must be placed by fax or online.

Updates

Dealers are responsible for the forwarding of product update information or updated products to customers that you have sold product to.

OPTIONS:

1. Updates to be forwarded to customers within 5 business days from receipt of information or products.
2. Provide the customer sales list pertaining to that product and HR will supply updates or product directly to the customer.

HR will keep customer names confidential.

Return Merchandise

Returns must have prior approval and authorization with RMA # before returning merchandise. Returns may not exceed 2% of your annual purchases, and are subject to a 15% restocking/repackaging fee. Merchandise must be shipped prepaid and arrive in new condition. On all returns distributors account will be credited.

CONTRACT TERM

The initial term of this Agreement shall be twelve (12) months from the date of this agreement Upon the express written consent of both parties, this agreement shall be renewed for one or more additional twelve (12) month terms.
